# Letter from the Vice President for Research

Dear Colleagues,

It's only February, but I want all investigators to be aware of an important change coming this summer. On July 1, we will transition from COEUS to the new Grants module in myResearch for submission of research proposals. "Grants" is one of six modules from Huron's Click suite being implemented across the University to streamline many of the administrative functions that investigators perform as part of their sponsored research. The new Grants module offers much greater functionality and ease of use compared to COEUS, which will cease operation after June 30th. In this newsletter, our Research-IT Team provides a detailed timeline for the transition. I cannot emphasize enough how important it is that Pls remain aware of this timeline — as well as sponsor deadlines — and plan their

proposal preparation and submission accordingly. Training for the new online module will be available in May. After the Grants module is live, our attention will turn to the IRB module and an Agreements module, both of which should be implemented over the summer.

Every year, the University provides research expenditure data to the National Science Foundation for the Higher Education Research and Development (HERD) Survey. The Office of Institutional Research, Planning and Effectiveness did the heavy lifting this year to compile our FY17 expenditure data for this survey. I am very pleased to report that our total R&D expenditures for FY17 were nearly \$239M, a record high for Stony Brook. Notable increases were seen in sponsored awards from NIH and NSF. And for more welcome news, our expenditures for FY18 are on track for continued increase.

This growth in our research enterprise places greater demands on research support units, which have not seen proportional expansion to keep pace. In the last Research Newsletter, I noted that the campus-wide project, Facilitating Researcher Success, was completed in late 2017, and the final report was presented to the President and other senior leadership across the University. Many of the recommendations in this report call for investments that will enable OVPR and other units to provide better support for investigators as our research activity grows. The final report is now available on the FRS webpage. Some recommendations that involve procedural changes are already being implemented. We will update the FRS webpage with these changes as they are completed. As always, your feedback about the effectiveness of the changes, as well as other recommendations, are welcome.

In the next week or so, many Pls will be receiving a request to participate in a Faculty Workload Survey sponsored by the Federal Demonstration Partnership. I encourage you to spend more time to complete this survey. The results are important for informing federal agencies of administrative burdens associated with performing sponsored research. This should be a concern for all of us, especially as we begin to implement changes to reduce administrative hurdles within the University.

As you scan through this newsletter, we hope you'll notice the new format, which is intended to make it easier to view, especially on mobile devices. In an effort to highlight our research beyond the campus community, OVPR has partnered with the Marketing and Communications team to create an email "Research News". This will afford an opportunity to showcase recent research findings from Stony Brook investigators. Distribution for the pilot project will target the research offices of other AAU universities. Stay tuned for further details.

Finally, I encourage you to share comments and concerns with me about any aspects relating to our research infrastructure.

### **Coeus Deactivation**

- On July 1st, Coeus will be discontinued and no longer accessible for either submission or viewing.
- Important documents that are only available for access in Coeus need to be downloaded and stored elsewhere.
- In order to provide OSP with a proper phase out, Coeus proposals should be submitted by June 22th.

### **Training Available**

- Training on Coeus will discontinue at the end of April.
- Regular ongoing training on *myResearchGrants* will start in early May. It will be held in the Frank Melville Jr. Memorial Library twice a week during the months of May and June. Registration will begin mid-April. Information will be shared as we get closer to the registration opening.

Our goal is to make the transition from our current Faculty Funding Database to PIVOT seamless so that faculty are able to find new and exciting funding opportunities right away. # News from OTLIR

## **Exclusive License Agreements**

AJES Life Sciences LLC, a Stony Brook based R&D company, has licensed University patents to develop therapeutics for osteoporosis and other bone-related diseases. Osteoporosis is a debilitating and painful bone disease that affects over 200 million people worldwide and



- is also responsible for a significant financial burden on healthcare systems each year. These licensed patents cover short peptide(s), discovered in the laboratory of Dr. Srinivas Pentyala and were shown to promote bone matrix production in early preclinical studies.
- Artelo Biosciences, Inc, a public company located San Diego, has licensed two technologies developed by Dr. Iwao Ojima (Department of Chemistry), Dr. Dale Deutsch (Department of Biochemistry and Cell Biology) and Dr. Martin Kaczocha (Department of Anesthesiology). Dr. Deutsch and Dr. Kaczocha uncovered that endocannabinoid inactivation is modulated by Fatty Acid Binding Proteins (FABPs) which deliver the endocanabinoids from the cell surface to their internal cellular binding proteins. Dr. Ojima has created novel

small molecules, which reversibly bind to FABPs and effectively block the transport of endocannabinoids. Artelo Biosciences will develop the FABPs inhibitors as a treatment for cancer and pain.

Openness in Research

**SUNY Policies** prohibit the acceptance of any awards that:

- Restrict dissemination of research results (Document 1800) and/or
- Restrict foreign national participation (Document 1801)

These restrictions apply to both written and verbal agreements with an external entity or sponsor.

Are There Any Exceptions to the Policies?

Requests for justifiable exceptions to this policy, on a case-by-case basis, such as for the purpose of protecting state and national security, must be submitted to the Office of Research Compliance for submission for Chancellor or designee authority's approval.

Any projects that are granted exceptions to these SUNY policies will be further reviewed for the need of a Technology Control Plan and/or export licenses.

## **International Travel Reminders**

Travel to Cuba or Iran for either Stony Brook University travel or personal travel if travelling with Stony Brook University items requires the prior review and approval of the Export Control Officer in the Office of Research Compliance. Please contact Susan Gasparo

For any international travel, if you are taking items, technology or non-published information with you when you travel, please review the <u>International Travel Guidance</u>.

Important Updates and Reminders to our Human Research Protection Program (HRPP)

The following are important Updates and Reminders to our HRPP. Please review them carefully!

# I. Effective and Compliance Dates of the Revised Common Rule have been postponed to July 2018 (at least)

See the federal register <a href="here">here</a>, and note: "Federal departments and agencies listed in the Interim Final Rule (IFR) are also in the process of developing a notice of proposed rule making (NPRM) seeking public comment on a proposal for further delay in the required implementation of the revised Common Rule (for example, until January 21, 2019)."

We will continue to monitor the situation, while concurrently working toward an easy transition for implementation of the new rule requirements when compliance with the final rule becomes required.

## II. January 25th marks the implementation date for the new NIH single IRB Policy

As we have been advising you for some time now, this sIRB Policy affects multi-site studies involving non-exempt human subjects research funded by NIH, and applies to grant applications with due dates on or after January 25, 2018 and R&D contracts in response to solicitations issued on or after January 25, 2018.

A new Special Topics Section to our updated Standard Operating Procedures (SOPs) (see section IV below) has been added that addresses the process for IRB Reliances and NIH sIRB here at SBU. # III. Reminder: IRB Approval does NOT mean Approval to Begin your Study!

IRB approval is just one aspect of complying with institutional requirements for the conduct of human research. Ancillary reviews and approvals are required before the commencement of studies using the facilities and patients of University Hospital, involving reviewers responsible for sign-off in the following areas:

- Pathology
- Research Pharmacy
- Radiology
- Privacy/Security (HIPAA)
- Hospital Finance/Billing Chair of PI's department
- Use of research-related radiation
- Use of surgical pathology or cytology specimens

#### IV. Our HRPP Standard Operating Procedures have been Updated!

For the past year, we have been preparing for our second re-accreditation with the Association for the Accreditation of Human Research Protection Programs (AAHRPP), and as a result, our SOPs have been extensively reviewed and updated.

We have posted them at this time as a single pdf <u>here</u>, but will create a more user-friendly format to allow for easy navigating in the near future. Please refer to these SOPs often to ensure the compliant conduct of your research activities.

Some of the more substantive changes you will notice:

- Revisions to reflect the changes in FDA and NIH regulations over the past few years (and sent to you via this mailing and/or in Research News) including, e.g., the NIH GCP training requirement, allowance of FDA waiver of consent for minimal risk research, NIH single IRB requirement, etc.)
- 2. Revisions to reflect the (impending) move from IRBNet to Click as our IRB electronic management system.
- Detailed SOPs on IRB reliance arrangements in Multi-site Research (see, in particular, Section17.16)
- 4. Section 3.8.2.1 ('Recruitment of Subjects') identifies that SBU participates in ResearchMatch (see new section 17.13) and confirms that, when recruiting patients as potential subjects, first contact must be made by someone who has a relationship (e.g., treatment etc.) with the patient; This policy protects the patient's right to privacy.
- 5. Section 5.2 ('Definitions' within the 'Obtaining Informed Consent' section) provides greater detail, per the NYS Family Health Care Decisions Act, regarding the definition of a legally authorized representative who can give permission as a surrogate (in instances where an adult cannot consent for themselves).
- 6. Section 5.7 ('Documentation of Informed Consent') adds that, when using the short form procedure: In addition to receiving a copy of the (English) summary and a copy of the short form at the time of consenting, the subject must receive a copy of the summary, translated into their native language, as soon as possible after their enrollment into the study.
- 7. Extensive revision to Section 7.5 ('Responsibilities for FDA-regulated Research') to be clear regarding responsibilities of FDA regulated Clinical Investigators as well as responsibilities of those investigators who are also sponsors of INDs and IDE's: see in particular Section 7.5.1.4 ('Additional Responsibilities When the Clinical Investigator is also the Sponsor of the IND or IDE ["Sponsor-Investigator"]') and support services now available for Sponsor-Investigators (Section 7.5.1.5)


- 8. Section 14 (Conflicts of Interest in Research) was revised to reflect the new annual disclosure process utilizing the electronic myResearch program.
- 9. Section 17.4 ('Registration of Clinical Trials') clarifies which research activities are subject to the clinicaltrials.gov registration requirement.
- 10. New Special Topics for:
  - 1. Genomic Data Sharing (GDS) for NIH Grant Submissions (Section 17.12);
  - 2. ResearchMatch as a Recruitment Tool (Section 17.13);
  - Conducting Research in a Clinical Setting (e.g., University Hospital):
     Special Considerations (Section 17.14);
  - Additional Requirements for Studies Funded by the Department of Defense (Section 17.15);
  - 5. IRB Reliance/Single IRB (sIRB) Review (Section 17.16)

# Grants.gov Workspace - Reminder to register now!

On December 31, 2017, <u>Grants.gov</u> retired its legacy, downloadable PDF application packages and applications are now required to be submitted through <u>Grants.govWorkspace</u>, a shared, online environment where multiple users can simultaneously work on different forms within an application package.

This does not apply to proposals submitted through NSF Fastlane, NIH ASSIST, or NASA NSPIRES.

Each user must register as an Organization Applicant using DUNS 804878247.

### **NSF Updates**

### **NSF Proposal and Award Policy Newsletter**

The newest edition of NSF's Proposal & Award Policy Newsletter can be found here.

Please note an important change in this edition. Besides updates on manytopics, NSF has included a new Proposal and Award Policies and Procedures Guide (<u>PAPPG</u>) effective January 29, 2018.

Significant changes include:

- The addition of an eligibility subcategory for international branch campuses of U.S. Institutions of Higher Education;
- The eligibility standards for foreign organizations has been revised;
- The standard Collaborators and Other Affiliations (COA) template which had been in a pilot phase since April has been implemented;
- The Budget Justification page limitation has been increased from 3 to 5 pages;
- The Project Description must now contain a separate section specifically identified as "Intellectual Merit":
- A restructuring of coverage on grantee notifications and requests for approval from NSF, including referral to the Prior Approval Matrix available on the NSF website.

#### **New York Paid Family Leave Program**

Starting January 1, 2018, the New York State Paid Family Leave (PFL) program will provide Research Foundation employees job protected paid leave to bond with a new child, care for a loved one with a serious health condition, or help relieve family pressures when someone is called to



active military service. This benefit is paid for by employees through payroll deductions and is not optional for most employees.

The PFL will phase in over the next few years:

- 2018 An eligible employee will receive 50% of their average weekly wage for up to eight weeks.
- 2019 An eligible employee will receive 55% of their average weekly wage for up to ten weeks.
- 2020 An eligible employee will receive 67% of their average weekly wage for up to twelve weeks.

The average weekly wage payable during a qualified leave is capped at the New York State average weekly wage which is currently \$1,305.92.

Minimum Wage Increase

As of December 31, 2017, the minimum wage for Long Island increased to \$11 per hour and the minimum wage for New York City increased to \$13 per hour. See the chart below for future scheduled increases to the minimum wage.

## Research Project Assistants - A Reminder

Last May, Richard Reeder and Chuck Taber advised Pls that the Research Foundation of SUNY and the Communication Workers of America, Local 1104, reached an agreement with regard to the Research Project Assistants' Collective Bargaining Agreement. They noted that Research Project Assistants would receive a biweekly increase of \$11.54 to their 2017-2018 academic stipend. This increase was processed for the paycheck dated February 2, 2018. For the 2018-2019 academic year, Research Project Assistants are scheduled to receive an increase of \$7.69 to their biweekly stipend.

#### Post Doc Hiring

Human Resource Services receives a number of questions about the search and selection of post-doctoral associates and senior post-doctoral associates. These are unique positions and we recognize the need for a streamlined hiring process and the importance of providing options for Pls. To accelerate the hiring process, assist in outreach and to provide an immediate applicant pool, Human Resource Services places a Post Doc Omnibus Ad. scheduled to run in the Spring post doc edition of Science and Fall post doc editions of Science and Nature, the omnibus ad promotes post doc opportunities while directing applicants to postings listed on the University's JOBS page. There is no cost to the departments, the ad eliminates delays in hiring by providing a mechanism to continuously collect resumes, ensuring a ready and immediate applicant pool. An ad in Science will be appearing in the January 26th print issue and 8 weeks on the Science careers website. All departments are encouraged to post their opportunities to the University website whether or not they have secured specific funding at this time. ### 2018 Tax Information and Supplemental Retirement Contribution Limit Update

The following is provided for your information. Tax questions may be referred to RF Payroll at <u>631-632-6162</u>. Questions regarding contribution limits may be referred to HRS Benefits at <u>631-632-6180</u>.

- The Social Security tax withholding rate is unchanged at 6.2%. The Social Security tax wage base has increased to \$128,400.
- The Medicare tax withholding rate remains the same at 1.45% with no limit on the Medicare wage base. Generally those employees that earn at least \$200,000 will have an additional 0.9% withheld after \$200,000.
- Tax "exemption" of employer paid "qualified" moving expense reimbursements are suspended until 2026. As a result all moving expense reimbursements to an employee will be subject to applicable taxes.
- The IRS maximum contributions for TDA or SRA accounts, or for the New York State Deferred Compensation plan, have been increased to \$18,500 per year. Those who are 50 years of age or older may contribute an additional \$6,000 per year.

Employees wanting to make changes to their tax withholdings or to update their contribution amounts may do so through Employee <u>Self Service</u>.

<u>Campus Wide OVPR Generated Salary Offset</u> <u>Transactions -Implementation Delayed</u>

It has been determined that launch of the OVPR generation of Salary Offset Transactions, (IFR) should be delayed until after the implementation of myResearch Grants.



The OVPR has been providing this service to the School of Medicine Departments for more than eight years and it has proven to reduce administrative effort on the part of Principal Investigators and their staff, as well as ensuring that the university is compliant with the expectations of federal funding agencies with respect to committed effort for research awards.

Once myResearch Grants is implemented, the OVPR will provide guidance regarding this process, with an outline of the procedure for this important service improvement and campus wide process.
